1. [www.canada.ca](http://www.canada.ca) -> English or French -> Sign into your CRA account -> Sign in using your existing credentials. If you do not have an account, you will need to register for one. Please see the guide, "Register for a CRA Account."





- **Business number (BN) of a business:** It is a 9-digit identification number, if you enter a BN, you are authorizing CRA to deal with anyone from that business.
